3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Caring for Survivors5 Act of 2021".

1SEC. 2. INCREASE IN AMOUNT OF DEPENDENCY AND IN-2DEMNITY COMPENSATION FOR SURVIVING3SPOUSES.

4 (a) INCREASE.—Section 1311(a) of title 38, United
5 States Code, is amended in paragraph (1), by striking "of
6 \$1,154" and inserting "equal to 55 percent of the rate
7 of monthly compensation in effect under section 1114(j)
8 of this title".

9 (b) Effective Date.—

(1) IN GENERAL.—Except as provided by paragraph (2), the amendments made by subsection (a)
shall apply with respect to compensation paid under
chapter 13 of title 38, United States Code, for
months beginning after the date that is six months
after the date of the enactment of this Act.

16 (2) SPECIAL RULE FOR CERTAIN INDIVID17 UALS.—

18 (A) IN GENERAL.—For months beginning 19 after the date that is six months after the date 20 of the enactment of this Act, the Secretary of 21 Veterans Affairs shall pay to an individual de-22 scribed in subparagraph (B) dependents and 23 survivors income security benefit under section 24 1311 of title 38, United States Code, in the 25 monthly amount that is the greater of the fol-26 lowing:

more years" and inserting "five or more years".
