9	"(A) is located at, or in proximity to, a
10	Department medical facility;
11	"(B) is available for residential use on a
12	temporary basis by patients of that facility and
13	others described in subsection (b); and
14	"(C) is constructed by, and donated to the
15	Secretary by, the Zachary and Elizabeth M.
16	Fisher Armed Services Foundation or the Fish-
17	er House Foundation, Inc.".
