OPENING STATEMENT OF HON. JOHNNY ISAKSON, CHAIRMAN, U.S. SENATOR FROM GEORGIA

Chairman ISAKSON. I call order to this meeting of the Committee of Veterans' Affairs.

Senator Tester. Mr. Chairman, I move that the Committee favorably report the rules of procedure for the 116th Congress and the original resolution authorizing expenditures by the Senate Committee on Veterans' Affairs.

Chairman ISAKSON. Is there a second?

Senator ROUNDS. Seconded.

I'm supposed to make a speech down the hall now, so I'm going to excuse myself if you don't mind. I'll turn it over to my able vice chairman, Mr. Tester from Montana. Looking forward to a good year. Thank you all for being here, I appreciate your support on everything.

Committee MEMBER. Those of us that were here, are we recorded? Can we leave?

Chairman ISAKSON. You've all turned in your proxies?

Committee Member. We have.

Senator Tester. Yes, you guys can leave.

Chairman ISAKSON. I've voted and y'all have voted. Everyone in here has voted because we had no objections. So, we've only got two left.

Senator Tester. Who takes the proxy votes in lieu of the person who comes in?

AIDE. I believe they'll go to Barry, the Chief Clerk.

Senator Tester. Where is he at?

AIDE. He's trying to help track down Members.

Senator Tester. When he gets in, send him over. I'll just give them to him and we'll go from there.
