A BILL

To improve the emergency management capabilities of the Department of Veterans Affairs, and for other purposes.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Advancing VA's Emer5 gency Response to (AVERT) Crises Act of 2025".

6 SEC. 2. REPORT ON EMERGENCY MANAGEMENT ROLES7FOR DEPARTMENT OF VETERANS AFFAIRS.

8 (a) IN GENERAL.—Not later than 180 days after the
9 date of the enactment of this Act, the Secretary of Vet10 erans Affairs shall submit to the Committee on Veterans'

 the roles and responsibilities of all offices of the Depart ment of Veterans Affairs involved with emergency man agement.

6 (b) CONSULTATION.—In preparing the report re-7 quired by subsection (a), the Secretary of Veterans Affairs 8 shall consult with the Comptroller General of the United 9 States, the Inspector General of the Department of Vet-10 erans Affairs, the Secretary of Homeland Security, and 11 such other Federal agencies as the Secretary of Veterans 12 Affairs considers relevant, to obtain insights from their 13 experience and trends that they have found, and such recommendations as they may have with respect to the man-14 15 agement by the Department of Veterans Affairs of emergency management functions. 16

17 (c) CONTENTS.—The report submitted pursuant to18 subsection (a) shall include the following:

(1) A description of the organizational structure
of each office, both during normal operations and
during emergency or disaster operations.

(2) The roles and responsibilities of each office.
(3) A detailed description of roles and responsibilities that are shared by both the Office of Emergency Management of the Department and the Of-

5 SEC. 4. PLAN TO ALLOW FUEL SHARING AND INCREASED
6 COORDINATION BETWEEN THE FEDERAL
7 EMERGENCY MANAGEMENT AGENCY AND
8 THE DEPARTMENT OF VETERANS AFFAIRS.

9 Not later than 90 days after the date of the enact-10 ment of this Act, the Secretary of Veterans Affairs shall, 11 after consulting with the Administrator of the Federal 12 Emergency Management Agency, submit to the Com-13 mittee on Veterans' Affairs of the Senate, the Committee on Veterans' Affairs of the House of Representatives, the 14 15 Committee on Homeland Security and Government Affairs of the Senate, and the Committee on Homeland Security 16 17 of the House of Representatives a report regarding—

(1) the current limitations preventing the Federal Emergency Management Agency from providing
fuel or other resources to the Department of Veterans Affairs during emergencies;

(2) whether the Department requires action by
Congress to allow such resource provision to occur;
(3) whether the Secretary has been unable to
coordinate with the Administrator during prior

1	emergencies or Fourth Mission activations due to a
2	lack of authority for such coordination; and
3	(4) whether the Secretary requires action by
4	Congress to address any of the issues mentioned
5	under paragraph (3).
